NOTIFICATION

No.9-3/2017-U.3(A): Whereas, the Central Government is empowered under Section 3 of the University Grants Commission (UGC) Act, 1956 to declare, on the advice of the UGC, an Institution of higher learning as an Institution deemed to be University.

- 2. **And whereas,** in exercise of powers conferred under Section 3 of the UGC Act, 1956, this Ministry, vide Notification No.9-3/2017-U.3(A) dated 29.11.2019, on the advice of UGC, declared Chaitanya Degree College (Autonomous), Hanamkonda, Warangal, Talangana as an Institution deemed to be University in the name of Chaitanya Institute of Science & Technology, Warangal, Telangana under general category for a provisional period of five years with prospective date.
- 3. And further whereas, this Ministry, vide Notification No.9-3/2017-U.3(A) dated 29.11.2019, rechristened the name of Chaitanya Institute of Science & Technology (Deemed to be University), Hanamkonda, Warangal to Chaitanya (Deemed to be University), Hanamkonda, Warangal.
- 4. And whereas, the President and Chancellor of Chaitanya (Deemed to be University), Warangal Telangana submitted a proposal on 07.07.2022 for shifting of Chaitanya (Deemed to be University) from Hanamkonda, Warangal to the vicinity of Hyderabad.
- 5. And whereas, UGC, vide its letter No.41-1/2020 (CPP-I/DU) dated 18.11.2022 recommended that the Ministry may accord 'In principal' approval to Chaitanya (Deemed to be University), Warangal for shifting of their main campus from Hanamkonda, Warangal to the vicinity of Hyderabad with certain conditions.
- 6. **And whereas**, this Ministry, on the advice of UGC, vide letter No. 9-3/2017-U.3(A) dated 29.12.2022, accorded 'In principle approval' to Chaitanya (Deemed to be University), Hanamkonda, Warangal for shifting of the main campus from Hanamkonda, Warangal to the vicinity of Hyderabad subject to the fulfilment of the following conditions:
 - i. The land at Hyderabad for Deemed to be University shall not be less than available at Warangal.
 - ii. The land should be registered in the name of Deemed to be University/Sponsoring Body.

- iii. The physical and academic infrastructure should be created at Hyderabad as required in the UGC (Institutions Deemed to be Universities) Regulations, 2016 and 2019.
- iv. The Deemed to be University will submit willingness of the students, faculty and non-teaching staff with regard to shifting of the campus.
- v. The Deemed to be University will submit NOC from the State Government of Telangana.
- vi. Since the Deemed to be University is also proposing to use Warangal campus for the Deemed to be University, the Warangal campus can be treated as Off-campus of the Deemed to be University. However, this shall be subject to the approval of the Warangal campus as off-campus by the Central Government as per the provisions of the UGC (Institutions Deemed to be University) Regulations, 2019. Till such time the Warangal campus is declared as an off-campus of the Deemed to be University by the Central Government, no academic activities shall be undertaken at Warangal campus after the campus is shifted to Hyderabad.
- vii. The "In Principal" approval shall not be treated as 'Final approval' and can be withdrawn at any point of time by the Central Government.
- 7. **And whereas**, the Institution, vide letters dated 30.03.2023 and 21.04.2023 submitted compliance report in respect of the above conditions. The compliance report and the clarifications of the Institution were considered by the Commission in its 570th meeting (Item No. 2.08) held on 27.06.2023 in which the following resolution was passed:

"The Commission considered and decided to recommend that the Ministry may consider approving the shifting of campus of Chaitanya deemed to be university from Warangal to Hyderabad. The Commission further decided to recommend to the Ministry that the Warangal campus of Chaitanya Deemed to be university will cease to exist from one year from the date of approval of new campus at Hyderabad."

- 8. **Now, therefore**, in exercise of the powers conferred by Section 3 of the UGC Act, 1956, this Ministry, on the advice of UGC, hereby permits Chaitanya (Deemed to be University) to shift its main campus from Hanamkonda, Warangal to the vicinity of Hyderabad. This permission is subject to condition that the Hanamkonda, Warangal campus of Chaitanya (Deemed to be University) will cease to exist after one year from the date of issuance of this Notification.
- 9. This permission is further subject to the fulfilment of the conditions of earlier notifications of this Ministry and also compliance to the relevant norms / rules / regulations / directions issued by the Central Government, UGC and other Statutory Councils, from time to time.
