II. How to apply

- Candidates have to submit their applications online at www.chaitanya.edu.in or offline at the Office of the Dean, Admissions by paying Rs. 400/- (Rupees Four Hundred only) without late fee as per the schedules shown below.
- The Office of the Dean, Admissions will not take any responsibility for the non-receipt of applications in time.
- Candidates have to submit separate application forms for each program.

III. How to take the Entrance Test

The test will be conducted three times. The candidate has the liberty to take any number of tests and the best score will be taken into consideration.

The candidates can appear for the Eligibility Test through our At-Home-Exam[®]. They can take the test from their home. They require a laptop or a TAB with a camera.

While appearing for the Eligibility Test, the candidate should not leave the Laptop or TAB until the examination is completed. There should not be any noise or disturbance during the examination. Candidates should not turn their heads left or right or move back from the Laptop or TAB screen. If they do so, the system stops automatically.
