II. How to apply

- Candidates have to submit their applications online at www.chaitanya.edu.in or offline at the Office of the Dean, Admissions on or before **April 08, 2025**, by Rs. 400/- (Rupees Four Hundred only) **without a late fee.**
- The Office of the Dean, Admissions will not take any responsibility for the non-receipt of applications in time.
- Candidates have to submit separate application forms for each program.

III. How to take the entrance test

The test will be conducted three times. The candidate has the liberty to take both the tests and the better score will be taken into consideration.

The candidates can appear for the Entrance Test through our At-Home-Exam[®]. They can take the test from their home. They require a Laptop or a TAB with a camera.

While appearing for the Entrance Test, the candidate should not leave the Laptop or TAB until the examination is completed. There should not be any noise or disturbance during the examination. Candidates should not turn their heads left or right or move back from the Laptop or TAB screen. If they do so, the system automatically stops.

6. Economically Weaker Section (EWS) certificate if applicable
7. Medical Certificate from not below the rank of a Civil Surgeon in case of Differently abled candidates.
